Travel Documents: All US citizens must carry a valid passport. Passports should be valid for a minimum of six months beyond estimated return date. In some countries, visas are not required for US citizens. If you are not a U.S. citizen, please contact QTS Tours and Travel to determine your visa requirement status approximately 6 months prior to departure. QTS Tours does not arrange for visa. It has to be done by the passenger

Air Transportation: Unless otherwise stated, all air travel will be economy class.
